



Hall of Fame Nomination Form – Person

Hall of Fame Criteria

- 1 Anyone can nominate a person for the Hall of Fame by submitting the listed criteria information to the American Paint Horse Foundation office.
- 2 Nominees will be screened by the APHF Hall of Fame Selection Committee, with emphasis placed on the following criteria:
 - 1) Their unselfish contribution to the Association rather than on their personal accomplishments.
 - 2) Selection should more or less parallel the chronological order of the contributions of the nominees, with the early APHA members having preference.
3. Membership in the Hall of Fame is a means of honoring the members whose efforts APHA could not exist without, and is not intended to merely congratulate people for being successful competitors, breeders, etc.
4. Deadline for nominations for the class of 2017 is December 1, 2016, and a final slate of recommended candidates will be presented to the APHF Board by the Hall of Fame Selection Committee. New inductees will be approved by the APHF Board and the APHA Executive Committee and will be announced in September and presented with a bronze trophy at the annual awards banquet. The APHF Heritage Committee will make every attempt to gather any pertinent memorabilia, photographs, etc. to be stored, with the idea of a Hall of Fame building in mind.
5. In addition to a completed nomination form, a minimum of two and a maximum of four unique letters of recommendation from different sources are required, as well as a photograph of the nominee. These may be attached and emailed to Laura Jesberg at ljjesberg@apha.com or mailed to her attention at PO Box 961023, Ft. Worth, TX 76161.

If you need more space, or prefer not to submit electronically, please submit it in writing on 8.5 x 11 sheets, (answering all the questions on the form) not to exceed a total of 4 printed pages. Nominations for Hall of Fame inductees will not be accepted verbally.

Nominees will automatically remain on the ballot for further consideration for a total of five (5) consecutive years, if not selected upon initial nomination. It is not necessary to re-nominate during that period; however, it is suggested that updated information be provided (such as updated contact information, additional awards, etc.) After a total of (5) years, the nominee must be resubmitted for consideration.
