## **Gillespie Maturity Stakes Conditions**

**Eligible Horses.** APHA or ApHC Registered Foals of 2019 and before are eligible to nominate to the Gillespie Maturity Stakes. Regular Registered APHA foals must have at least one regular registry paint parent in the first generation and solid registered APHA foals must have two APHA regular registered paint parents or at least one APHA regular registered paint parent in the first and second generation. TPHBA reserves the right to move, postpone, cancel, or otherwise alter the racing format of the Gillespie Maturity Stakes for worthy cause. It is the responsibility of the owner and/or trainer to make sure their entry is duly registered and eligible by meeting all conditions as published. Should a horse be declared ineligible, all fees paid in will be forfeited to the purse and not subject to refund.

**Payments.** Except as provided herein, the failure to make all payments on or before the designated dates will result in termination of the nomination and all prior nominating and sustaining payments will be forfeited. All payments must be postmarked no later than the due dates and should be sent by certified mail. Checks for nomination or sustaining payments that are returned constitute no payment

**Entry.** Entries in all races must be made through the entry box at Gillespie County Fair by closing time for entries in that race. All regular and usual office charges and jockey fees will be charged by track officials for each entry.

**Added Money and Purse Distribution.** The net purse for the Gillespie Maturity Stakes will include all fees. Final purse money distributed by track will pay ten (10) monies using the following formula: 38%, 17%, 11%, 8%, 6%, 5%, 4.5%, 4%, 3.5%, 3%. No purse money will be paid to Juvenile entries that are scratched for any reason prior to the running of the Juvenile. Any remaining purse money available with respect to such withdrawn horses will be distributed proportionately to those horses running in the Juvenile in accordance with purse distribution percentages. In the event there are fewer than 10 starters, the purse funds will be distributed proportionately between the actual number of participants based on the original formula for distribution. The Accredited Texas-bred money will be paid out to the top three best placing of an Accredited Texas-bred Paint Horse(s). ATB money will be distributed by TPHBA to be divided 50%, 30%, and 20%. If less than three (3) ATB horses star the ATB money will be distributed evenly to the remaining ATB horses.

Gillespie County Fair Association (GCFA) and Texas Paint Horse Breeders' Association (TPHBA) shall not be liable for, and the owner and lessees of the horse will indemnify and hold harmless the GCFA and TPHBA, against all responsibility or liability or claim for injury or damages to any person, horse or other property of the undersigned, or any other person whether by negligence or otherwise.

THE DECISION OF THE STEWARDS OR THE TEXAS RACING COMMISSION IN ALL MATTERS UNDER THEIR JURISDICTION SHALL BE FINAL
