Even in the midst of a still-challenging horse economy, APHA members, affiliates and employees should all feel a strong sense of pride and accomplishment this year. Not only is our Association celebrating its 50th anniversary in 2012, but our horse registrations recently surpassed the one million mark in 2011. These milestones are testaments to our Association's popularity, success and longevity.

In 2011, we continued to hold strong to our business plan set forth the year before. This plan focuses on improvements to revenue, membership, regional and international clubs, customer service and the website. It is clear that each of these areas is tightly woven with the others, and much like our whole Association, each works better and more efficiently if they all work together.

One exciting change in 2011 included solidifying a partnership with UC Davis to become APHA's exclusive genetic tester. Working with the California-based lab, as of January 1, 2012, we now offer a variety of testing options to our members. The new testing packages are designed to increase member awareness of the genetic possibilities when breeding their American Paint Horses. Included in the testing options are a comprehensive coat color package, comprehensive disease diagnostic package and selected individual tests.

In 2011, we took the initial steps to create an APHA Hall of Fame—an idea that has been tossed around for years. This will allow us to formally honor our greats, both equine and human, as never before. In 2012, we will induct our inaugural class of 25 horses and 25 people during our annual convention, in conjunction with the celebration of our 50th anniversary.

Our social media continues to amaze me. While our Twitter accounts remain popular, our Facebook page has exploded, reaching 50,000 fans before the end of 2011. This forum allows us to reach and interact not only with our members but also with potential members who love Paint Horses but have not yet taken that next step. We will continue to leverage this powerful and economical medium to get our message out there.

2011 was a year of change and new beginnings for APHA and for me. In early 2012, I passed the reins of Executive Director to Billy Smith. It is a job that comes with great pressure and responsibility, but also great rewards. I have complete faith in Billy's leadership abilities and look forward to working with him to reach new heights for our Association. I am proud of the work I have done and what you and I have accomplished together in my six-plus years as Executive Director. It has been a pleasure heading up the best breed organization in the world and I welcome the new challenges that await me in 2012.



January

- 2011 started the year with a total of 999,300 horses registered with APHA. There were 17,835 horses registered in 2010 and 24,830 transferred. Internationally, Canada, Germany, Italy and France had the most American Paint Horses registered in 2010. Memberships number 64,993 with 55,367 in the United States, 4,092 in Canada and 5,529 international. Texas and California have the most members in the U.S., Alberta in Canada and Germany internationally.
- The 2010 World Champion Racehorses were announced during the Heritage Place Winter Mixed Sale. Michigan-bred I Do One Two Three was named the Regular Registry World Champion for the second time and Rio Rojo Jessie named the Solid Paint-Bred World Champion. For the first time in APHA history, a Canadian Champion was also selected based on a decision made by the Racing Committee in 2010. The Canadian/International Champion was Paint Me A Bono, owned by Ivy Lane Racing in Stouffville, Ontario, Canada.

February

- The Spring issue of the *Paint Horse Connection* magazine paid tribute to APHA's many Facebook fans. The magazine utilized innovative technology to build the entire cover using photos submitted by the Association's Facebook fans to recreate the APHA logo horse head for the cover. Over 1,700 photos were used to assemble the mosaic. The artwork was later made into a poster as well as a puzzle, both of which were sold through APHA's General Store.
- APHA approved the first regional club in Australia on February 15, 2011, making Australia the first country to have to have both an APHA regional club and a Paint Horse registry.

March

- For the ninth year, the 2011 Breeders' Trust program featured million-dollar payouts. Nominated horses received \$14.47 for every Open and Amateur point. Zippos Sensation continues to sire the most money-earning Breeders' Trust foals, with 544 foals nominated to the program.
- APHA has entered into a 5-year sponsorship agreement with the Southern Belle Invitation program. The sponsorship allows The Southern Belle to run their Breeders' Classes concurrently with the APHA Open/Amateur World Championship classes.
- APHA joined Texas horsemen and women at the state capitol to support bills that would generate revenue for the state and provide support for the struggling Texas horse industry. Over 1,000 horsemen attended the rally to show support and encourage legislators to put the proposed legislation to a public vote in Texas. The rally was organized by the Texas H.O.R.S.E. organization, of which APHA is one of the founding members.

April

- The first official World Show qualification period began April 1, 2011, and will run through March 31, 2012, for the 2012 AjPHA Youth World Show. The qualification by participation rule was put into place at the 2010 Convention.
- On April 8, APHA's Facebook page reached the milestone of 40,000 fans. The 40,000th fan received 40 APHA branded items in celebration.

- An American Paint Horse named Mr Bay Jewel helped a trainer and celebrity team win the 2011 Reining With The Stars event on April 17. The celebrity was Ernie Rodina, a Purina Mills sales manager and Better Horses Radio host. The event raises money for the Susan G. Komen Race For The Cure philanthropy for breast cancer research.

May

- A widespread outbreak of Equine Herpesvirus (EHV-1) occurred after an National Cutting Horse Association event in Utah at the end of April. Multiple horses were involved. As result of this outbreak, APHA launched a "Health Updates" page, which was used to inform Paint Horse owners and members about the latest developments and containment of the disease. This page will be available in the event of future outbreaks of disease, with a full resource of reference documents, list of cancelled shows and events, and important contacts.

June

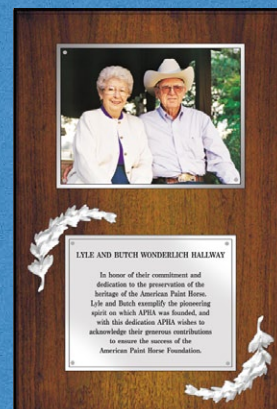
- Four topics took center stage during the APHA Workshop, namely combining the Workshop and Convention events into one, and three rule change proposals regarding performance halter classes, performance leases of horses and opening the registry to cropouts. While none of these hot topics were passed on for approval at Convention, 29 other rule proposals did pass and will be voted on at that time.

More than 100 active APHA members, including the Executive Committee, standing committee members and 86 of the 119 voting national directors attended the meeting to review 60 rule change proposals.

- A prominent hallway in the APHA headquarters was designated the Wonderlich Hallway, honoring Doc and Butch Wonderlich. The Wonderlichs are grassroots members of APHA and the Executive Committee made the decision to honor them for their dedication and service to the breed.
- The AjPHA Youth World Championship Show was held in Fort Worth, Texas, from June 24-July 2 incorporating jackpot "pay out" events alongside some of the traditional classes. The show drew 1,150 entries with 326 horses over the course of nine days and awarded over \$100,000 in cash and prizes. The All-Around 14-18 award went to Taylor Prince of Las Vegas, Nevada, riding One Flashy Sensation. The All-Around 13 & Under award went to Drew Rogers of Bakersfield, California, showing Shez Eye Candy. The All-Around Novice Youth and Reserve All-Around 13 & Under was Alexandra Marlow of Victoria, Texas, showing Glowin Easy.

The High-Point Western award went to Marcus Banister of Brighton, Colorado, with Sacreds Barbie Doll. The High-Point English award went to Halley Armstrong of Breckenridge, Colorado, showing Brother Jack Daniels. The Elegant April award went to Lauren Spivey of The Woodlands, Texas, showing A Son Of A Zip.

- In addition to 73 world-title classes, the Association also hosted a Youth Boot Camp for youth competing at the World Show. The camp allowed the youth to work with APHA professionals in preparation for the show. Other activities during the show included the AjPHA Year-End Awards Banquet, Paint For A Day, Youth Horse Judging Contest and the AjPHA National Convention.

July

- Sato, a dual-registered APHA and Jockey Club (TB) palomino overo stallion was named to represent APHA as a 2011 Breyer portrait model. The model became available at the Breyerfest held in Lexington, Kentucky, in July and is now available in stores. Sato made special appearances at the Breyerfest event and owner April Wayenberg signed the models.
- An agreement was reached with UC Davis to provide genetic testing services for APHA in 2012. UC Davis began offering genetic testing for parentage verification, color genes and diseases as of January 1, 2012.
- APHA announced the availability of web banners on several of the APHA websites as a promotional tool for Paint Horse enthusiasts and equine-related business owners.
- France hosted the first international APHA Youth Horsemanship Camp for AjPHA members in Europe on July 26-28 in Lyon, France.

August

- The qualifying period for the 2012 APHA Open & Amateur World Championship Show officially began August 1, 2011, and will run through July 31, 2012.

September

- The Association announced the creation of the APHA Hall of Fame, of which the inaugural class of horses and people will be inducted during the 2012 Annual Convention, to coincide with the Association's 50th anniversary celebration.
- West Texas A&M graduate Laura Stevens of Katy, Texas, joined the editorial staff of the *Paint Horse Journal* magazine. She has written for the American Quarter Horse Association as well as *Palomino Horses* magazine and *The Cattle Range*, a web-based company.
- The first Youth Judging Seminar was held in Germany for European Youth members on September 7, during the European Paint Horse Championships.

October

- Lex Smurthwaite, Executive Director of APHA, announced he would step down in 2012. He has served as Executive Director since 2005.
- Hardy Oelke of Halver, Germany, was awarded the Distinguished Service Award for 2011. Incoming APHA President, Scot Jackson, gave Oelke the award during the European Paint Horse Championship in Kreuth, Germany. This was the first time in APHA history that the award was given to a member outside the United States.
- The APHA Annual Convention was held in Vancouver, Washington. Attending were members of the Association's Executive Committee, 98 National Directors and other involved members from 35 U.S. states, two Canadian provinces and the United Kingdom. Scot Jackson of Stephenville, Texas, was sworn in as President of the APHA Executive Committee and George Ready of Hernando, Mississippi, was sworn in as the Sixth Committee Member. Some of the rule changes made at the Convention included transferring points and awards if a horse advances to Regular Registry, recognizing dressage and cowboy mounted shooting for APHA points and awards, and eligibility changes for stakes races with regards to Regular Registry lineage. The Youth Leadership Conference was held during the Convention, with youth working on marketing ideas, program development and problem solving sessions.

November

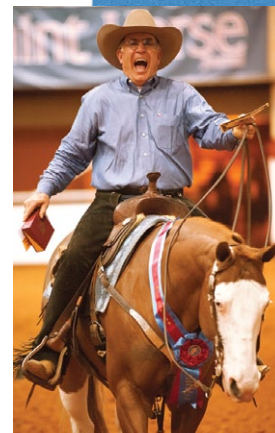
- The newest in equine identification technology was introduced to attendees of the APHA World Championship Show, prior to the official launch of the product. Global Animal Management demonstrated the eyeD technology at two events during the show, offering an introductory price to those interested in enrolling their horses.
- The Open & Amateur World Championship Show was held November 2-12 in Fort Worth, Texas. The total number of entries was 2,294 with payouts of over \$339,000 in cash to the top exhibitors at the show. In addition to the 178 world championship classes, slot, Breeders' Futurity classes, challenge and sweepstakes classes offered cash payouts instead of a championship title. The Open and Amateur reining and cattle classes were held during the show. The classes had previously been held in the summer. The list of new classes for the show included eight Southern Belle Breeders' classes, two National Snaffle Bit Association Stallion Incentive Fund classes, a Novice Amateur Hunt Seat Equitation Over Fences class and a Limited Division was offered in each slot class. The Breeders' Futurity added six performance classes for 2-year-olds in the program.
- The All-Around Classic Amateur was Chelsea Bain of Scottsdale, Arizona, riding Sensational Blonde. All-Around Masters Amateur was Coleen Bull of Reed City, Michigan, showing Timeless Assets. All-Around Novice Amateur was Kristen Shaw of Oregon City, Oregon, showing Too Hot To. Roses And Chocolate took home top honors, winning the All-Around Open Horse, Super Gelding and High-Point English Horse awards. High-Point Western Horse and Oscar Crigler Cattle Award went to Gay Bar Drummer. High-Point Exhibitor went to Ryan Painter of Pilot Point, Texas.
- The Breeders' Trust Select Sale was held on November 5, during the Open & Amateur World Championship Show. A total of 44 horses were consigned to the sale, with high seller Just Say Jose, a 2000 sorrel overo stallion, selling for \$10,500 to Jukka Kivela of Finland. A Yearling Sale Stakes session was added this year with 20 yearlings consigned. Yearlings selling in this session are now eligible to show in the 2-year-old Western Pleasure Sale Stakes class at the 2012 World Show.

December

- American Paint Horses dominated the standings at the 2011 National Reining Horse Association Futurity held in Oklahoma City, on November 24-December 3, amassing over \$116,000 in earnings at the event. Gunner Boy (Colonels Smokingun x Kat Jordan) with Brazilian rider Eduardo Salago were victorious in the Level 1 Open and Level 2 Open divisions of the Futurity, and tied to win the Level 3 until a runoff named him reserve. Spooks Gotta Run (Spooks Gotta Gun x Prettywhizasprettydoes AQHA) and Oklahoma rider Michael Jeffcoat won the Level 2 Non-Pro division and Prime Time Non-Pro division championships. Gunner Be Really Good (Colonels Smokingun x Bay Brim Hat AQHA) and German rider Felix Schnabel won the Level 1 Non-Pro championship and Level 2 Non-Pro reserve championship.

Distinguished Service Award

In 1983, APHA celebrated its 20th anniversary by creating a Distinguished Service Award, to be presented annually at the APHA National Convention. The award has been given each year (with the exception of 1988 and 2002) to a special APHA member who has helped the Association make significant strides.



Hardy Oelke of Germany Receives Distinguished Service Award

For more than 35 years, Hardy Oelke, the first international recipient of APHA's Distinguished Service Award, has demonstrated his passion for the American Paint Horse and dedication to the American Paint Horse Association.

Oelke helped to cultivate Europe's love affair with Paint Horses beginning in the 1970s. A pioneer in Western riding, he helped found the Paint Horse Club Germany, and organized its involvement in the Equitana and Americana events. Oelke's commitment to Paint Horses extends beyond any one style of riding; he also helped bring Paint racing and APHA's first approved show to Europe.

Through his love of photography and writing, Oelke brought vivid illustrations and moving descriptions of the Paint Horse to its rapidly growing fan base overseas. His book, *The Paint Horse: An American Treasure*, examines Paint Horse history and culture. Originally published in German, the book was translated into English and garnered success across the globe.

As a breeder, trainer and exhibitor he has greatly improved the quality of Paint Horses in Europe. He trained and showed the first APHA Champion in Europe named Clarke Kent. Hardy was the first European to compete at the APHA World Show. He has also imported numerous quality Paints and helped others do the same.

"Hardy has been a driving force behind the success of our breed internationally," said APHA Executive Director Lex Smurthwaite. "He has generously and freely given service that has resulted in continuing, valuable and lasting contributions to APHA."

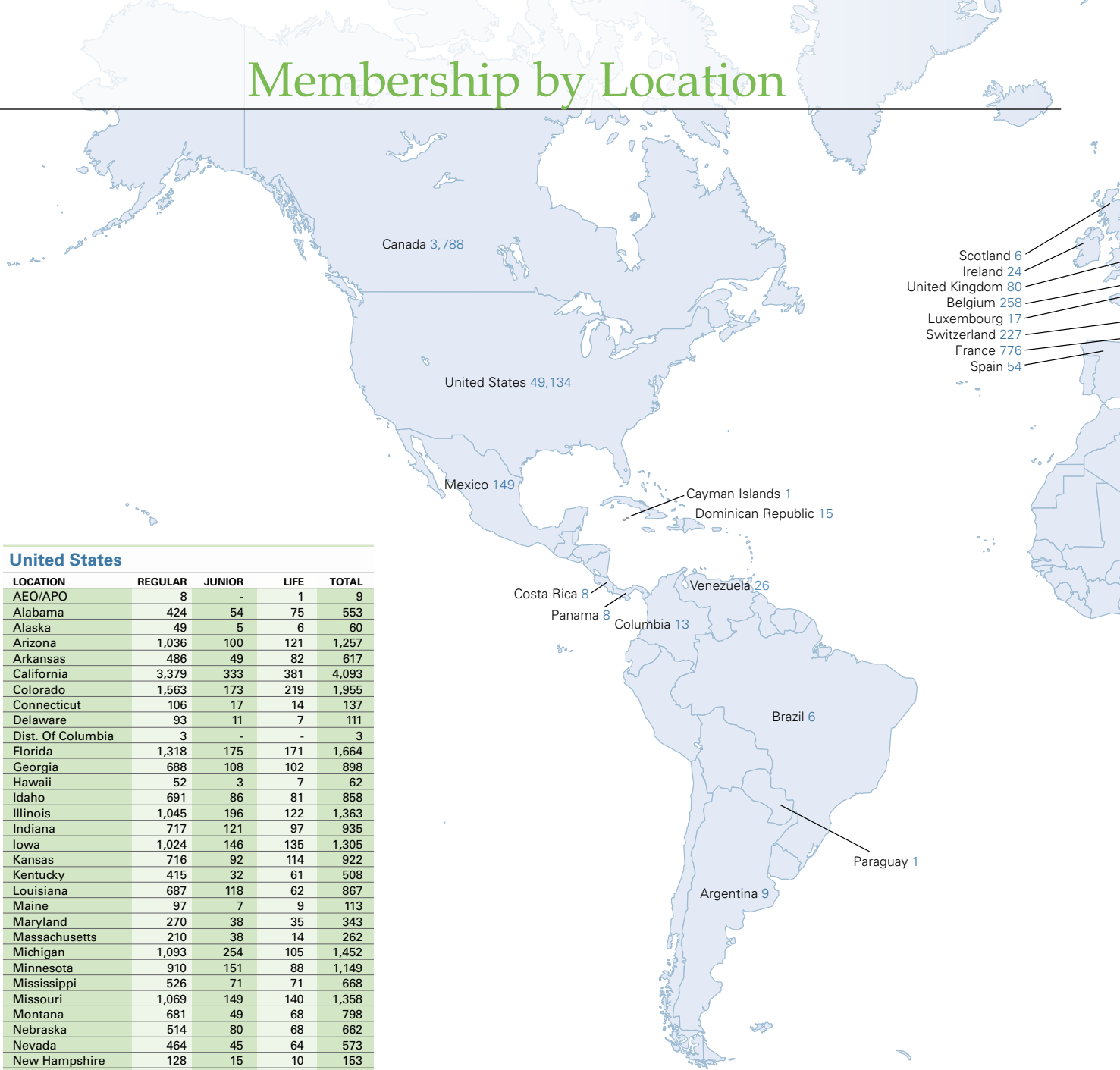

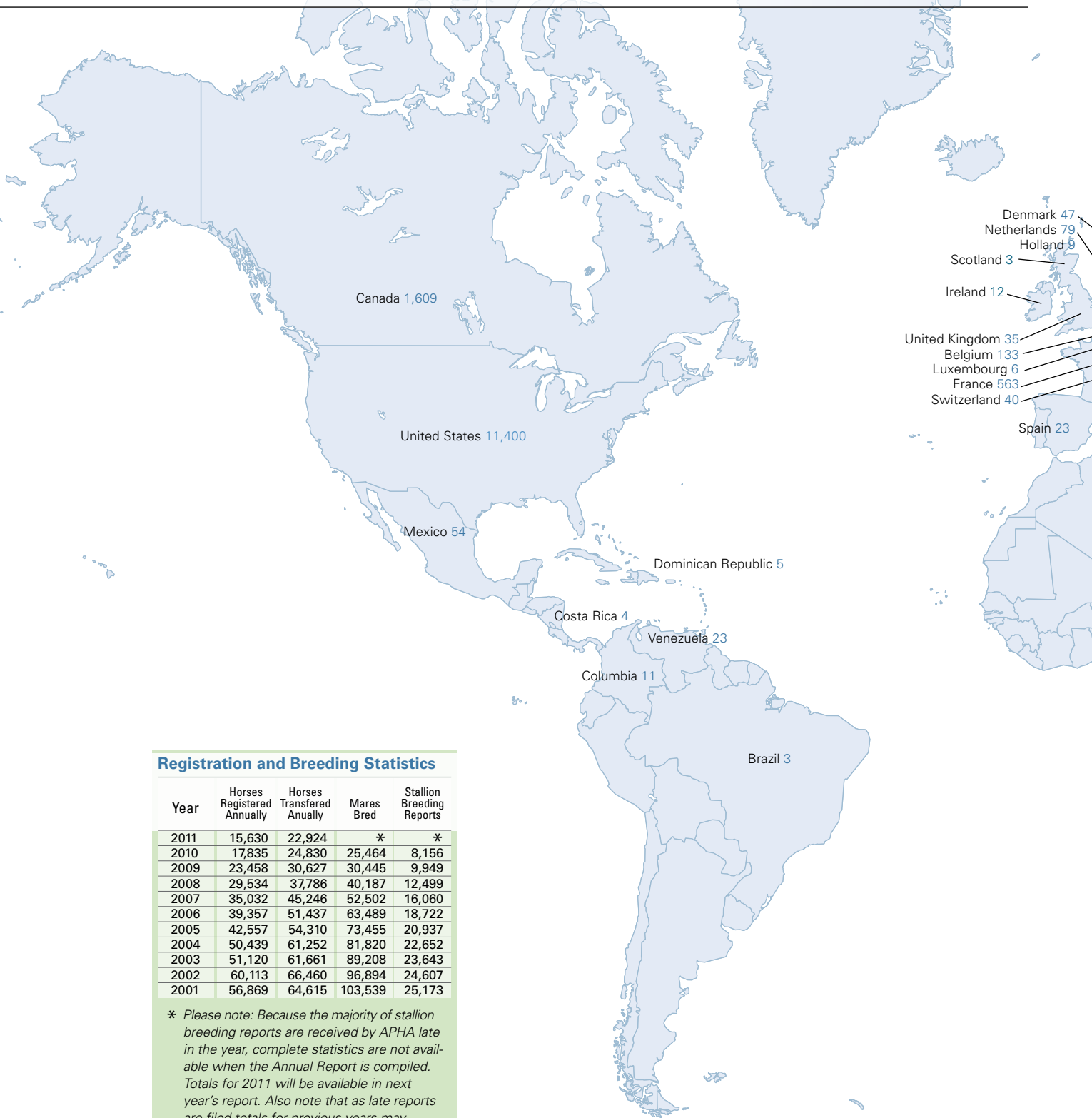


Cumulative Total Horses Registered

in thousands since 1962



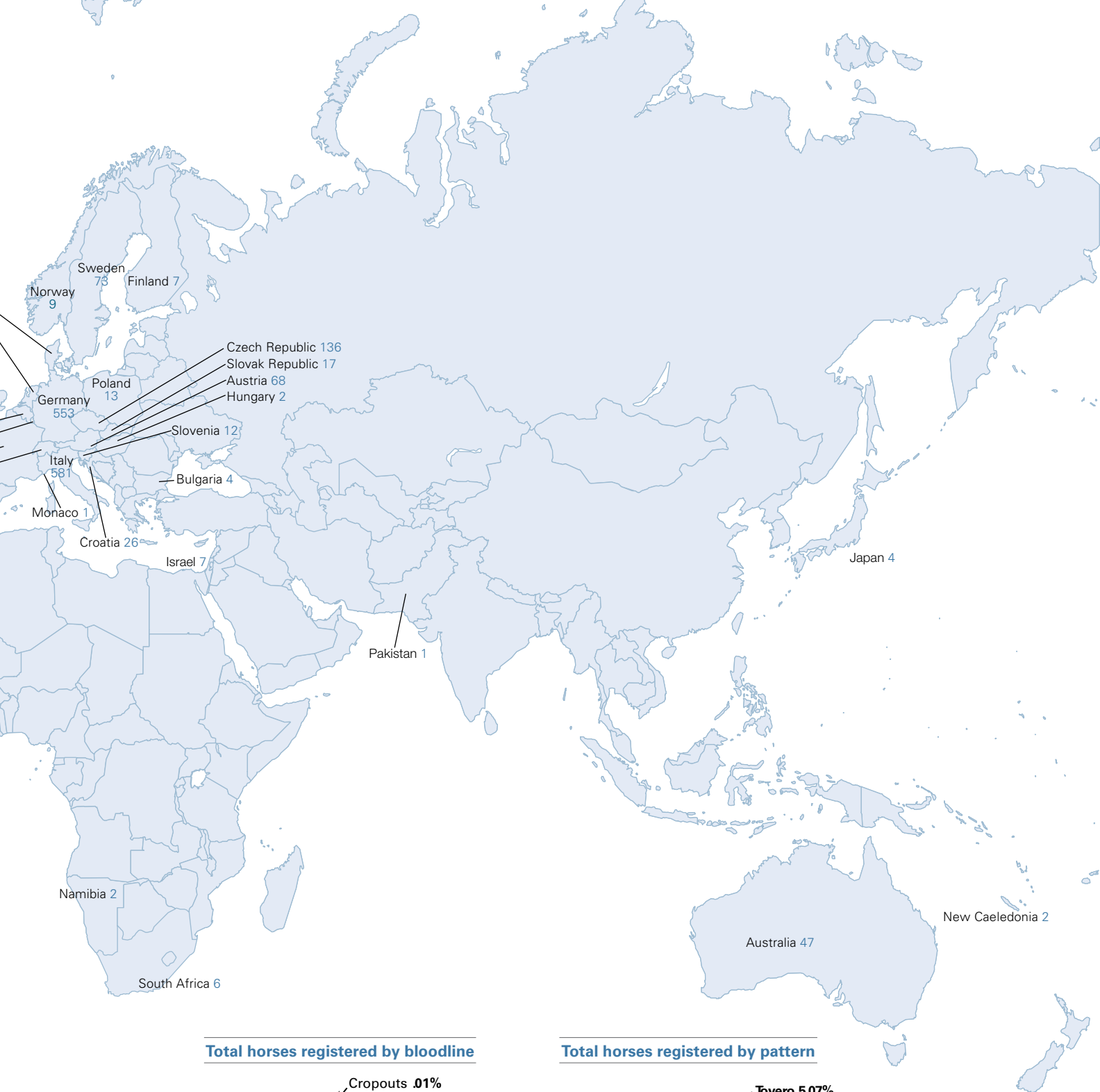
Paint Horse Distribution (Total horses registered in 2011)



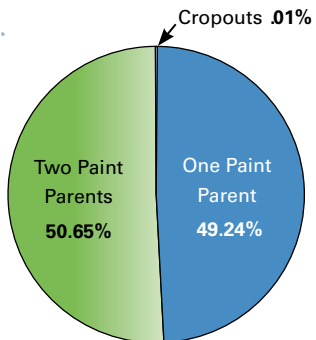

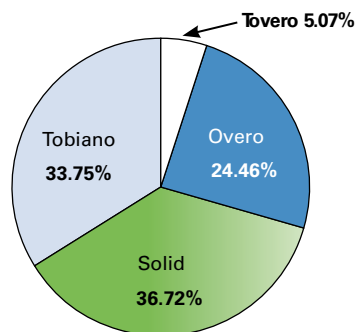

Total horses registered by bloodline



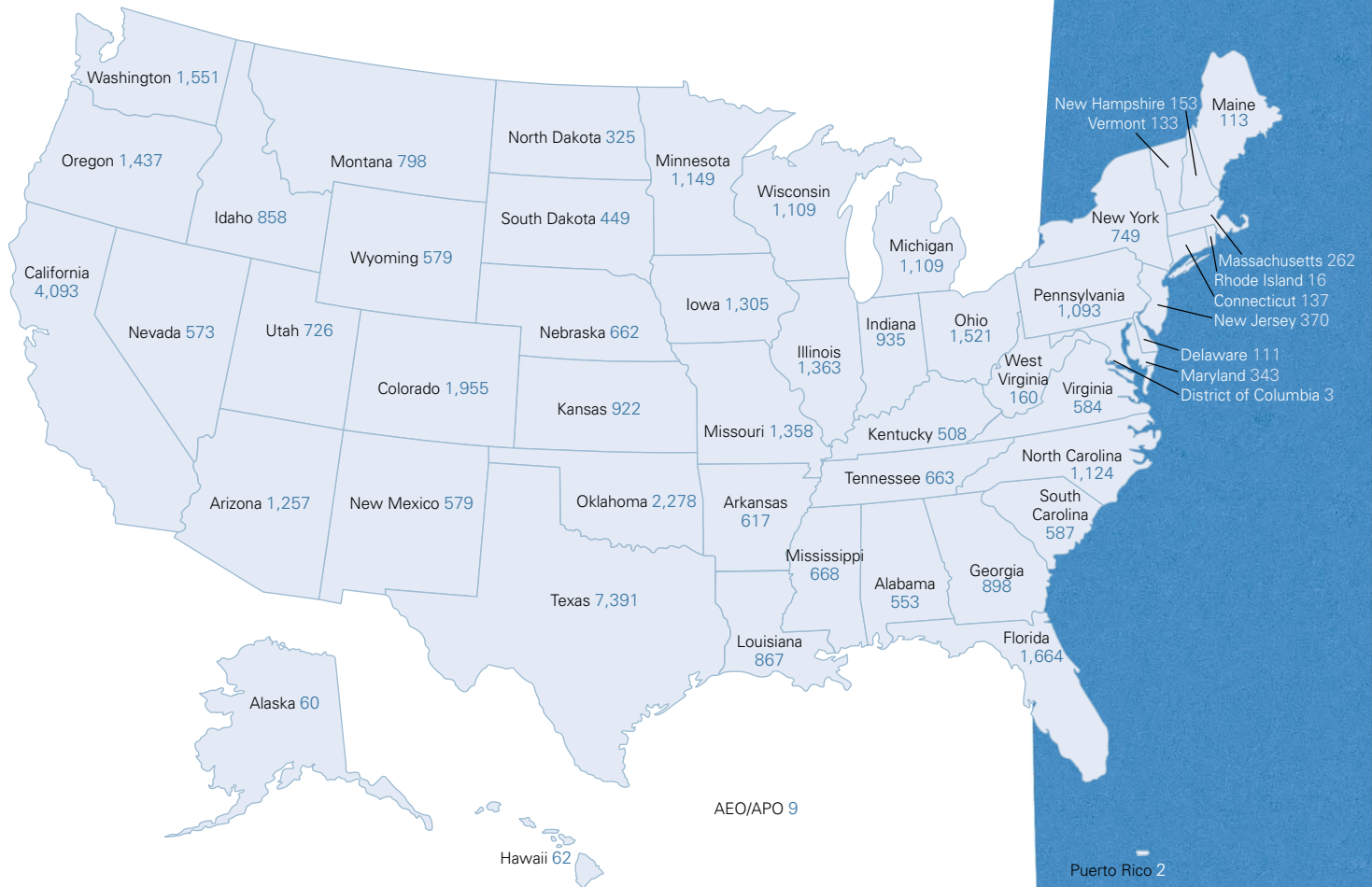
Total horses registered by pattern

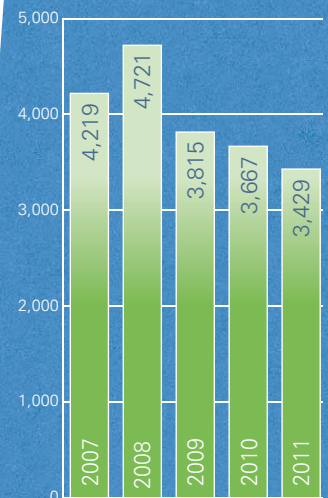

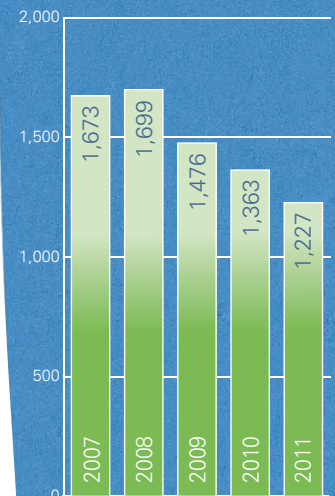

Incentive Programs

Breeders' Trust records another successful year

In 2011, the incentive program for Paint Horse owners, exhibitors, racers and breeders boasted a total of \$859,649.85.

Breeders' Trust funds are based on a point system, with each point being worth a specific amount of money. The 2011 value was \$11.57 per point. Yearly dividends are paid to subscribed stallion owners, foal nominators and recorded owners of horses enrolled in the program. The stallion subscriber receives 20 percent of the dividend, the foal nominator 10 percent and the foal's recorded owner on December 31 of the showing year receives 70 percent.



Zippos Sensation continued his reign as the Breeders' Trust Top Sire in 2011, capturing the title for the 11th time. Last year, 120 of his foals earned a total of 7,679 points worth \$88,883 in Breeders' Trust money.

#1 on Leading Sires List

If Paint Horses were royalty, Zippos Sensation might just be king. The 1993 sorrel overo stallion has presided over the No. 1 Breeders' Trust sire position since 2001, a record 11 years of discernable impact on the breed.

In 2001, Zippos Sensation first earned the No. 1 spot on the Breeders' Trust leading stallions list. And every year since, the 1993 sorrel overo stallion has attained that top rung.

Bred by Joe Bachmuth of Cullman, Alabama, "Zippo" is by Zippo Pine Bar (QH) and out of Satin N Lace. After Zippo suffered an injury that cut short his promising show career, the late Lynn Simons channeled the stallion's potential toward breeding—a perfectly orchestrated move. From his first foal crop in 1996, Zippo made siring excellence a habit.

In 2011, Zippo had 120 foals nominated to the Breeders' Trust earning a total of 7,679 points, averaging 64 points per foal. In 2011, those foals earned 495 more points than 2010, for a total payout of \$88,883.45.

The sire subscriber receives 20 percent of his offspring's Breeders' Trust earnings while the nominator of the foal receives 10 percent and the foal's owner receives 70 percent. The success of Zippo's foals last year earned the Simons a check for \$17,776.69.

At 19 years old, Zippo shows no signs of slowing down, nor ending his reign of the Breeders' Trust sire chart.

"I think his legacy will have been good-minded horses that do several events and are structurally correct," owner Andrea Simons said. He's kind of been our whole program, our whole motivation. He has given us real direction."

#1 Money Earner

Standing next to the striking bay overo, it's difficult not to notice the impressive stature and friendly personality that constitute Timeless Assets. When accompanied by his No. 1 cheerleader, owner Coleen Bull of Reed City, Michigan, "Tucson" seems larger than life, the superstar performer with an "aw, shucks" attitude.

In a year that captured a childhood dream for Coleen—winner of the 2011 All-Around Masters Amateur title at the APHA World Championship Show—"Tucson" also defended his title as the top Breeders' Trust money-earner. Born in 2005 to breeder Charlene Lee Maybury of West Jefferson, Ohio, Tucson is by Frozen Assets and out of This Times Divine. He was subscribed to the Breeders' Trust by Bunny Knaus of Monticello, Indiana.

The APHA Champion has claimed wins in a myriad of classes, ranging from overo color to trail, Western riding to hunt-seat equitation. In 2011, Tucson earned 1,749 Open and Amateur points worth \$20,244.62 while his owner received a check for \$14,171.24. Charlene Maybury took home \$2,024.46 as the gelding's nominator and breeder Bunny Knaus received a check for \$4,048.92

"When I started counting up points and comparing to last year, I began to think, 'Well, maybe we did it again,'" Coleen said.



Earning 1,749 points in 2011, Timeless Assets took home his second consecutive Breeders' Trust Top Earner title, along with a total payout worth more than \$20,000.

Breeders' Futurity has a successful third year

APHA's Breeders' Futurity program continues to gather steam. Established in 2009, this prestigious competition featured the finest American Paint Horses and exhibitors in the world competing in a select slate of classes during the APHA World Championship Show. The Breeders' Futurity is designed to showcase the offspring of Breeders' Trust-enrolled stallions and mares bred to those stallions. In 2011, the program boasted 115 entries vying for a total of over \$116,000 in purse money and awards in the four divisions—Platinum, Gold, Silver and Bronze.

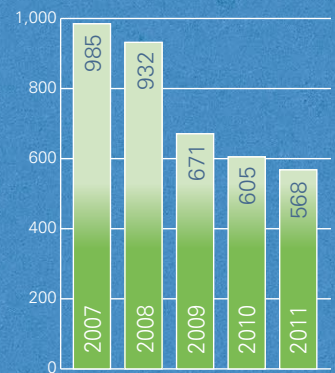

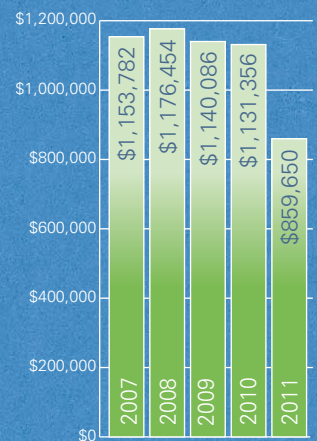

APHA Gelding Plus

Gelding Plus promotes Paint geldings four years old and older by paying out a potential \$42,000 at select APHA-approved events. With automatic enrollment for every APHA gelding who is officially registered as a gelding prior to the competition, \$3,000 was up for grabs at APHA Zone shows and select international shows. In 2011, 38 Paints received Gelding Plus payouts. To view the list of all 2011 winners with their photos, please visit apha.com/geldingplus.

As of December 31, 2011, the Gelding Plus Program has been discontinued. Beginning in 2012, funds will now be allocated to a new Regional Club Show Sponsorship Program with the specific intent of giving the incentive money a more effective and widespread use by our APHA Regional Clubs. We're excited for the opportunity to help strengthen our Regional Club network in a new way with the goal of increasing regional show participation, enhancing the exhibitor experience, encouraging creative show formats and stimulating membership recruitment for the regional clubs and APHA.

2011 was another exciting year for Paint racing with Flashthechicks making his presence known early on by winning three of the biggest stakes races for 2-year-olds: the RG1 American Paint Classic Futurity, the G1 Speedhorse Graham Futurity, and the RG1 Pot O' Gold Futurity. He also became the highest money-earning 2-year-old of all time finishing the season earning over \$186,000; was named the 2011 World Champion Solid Paint-Bred Horse, Champion Solid Paint-Bred 2-Year-Old, and Champion Solid Paint-Bred 2-Year-Old Gelding. Flashthechicks owner Shirley Wheeler was also named the 2011 Leading Owner and Breeder.

PF Chief Runnin Bear, or "Da Bear," dominated the stakes races in Texas, winning the Colors of the Wind and the G1 Olympia Joe Handicap, leading to his second world champion title along with Champion Aged Horse and Champion Aged Gelding. The 2006 brown tobiano gelding finished the year with a 98 speed index and \$143,373 in earnings.

Twenty-eight Paint track records were broken at various tracks in the U.S. with seven being broken by the 2011 champions.

The year also brought sadness as we lost three great broodmares and one champion. Judys Chick passed away in December at the age of 27. She produced 15 foals, three stakes winners and two Champions with earnings over \$203,000. Her legacy is carried through her foals Judys Lineage, Little Sara and A Sharper Image to name a few.

Lifetime leading broodmare Got A Grip died shortly after giving birth. The mare's offspring topped the charts once again in 2011 earning in excess of \$604,000 and includes five-time world champion racehorse Got Country Grip and his full-sister Girls Got Grip, who was the leading money-earner of 2010.

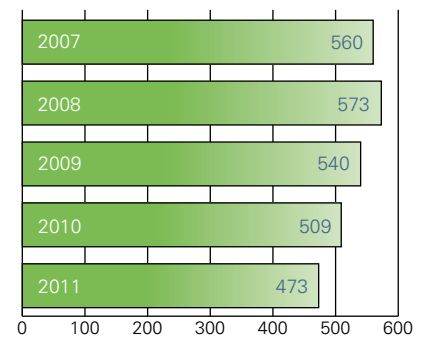
Call Me Silking died in December as well and is the dam of 2007 Champion Rio Rojo Jess and 2010 World Champion Solid Paint-Bred, 2011 Champion 3-Year-Old Solid Paint-Bred Filly Rio Rojo Jessie.

In Canada, the horse to beat was Independent Woman. The 4-year-old sorrel overo mare by Royal Quick Flash won the Millarville Paint Stakes in July and the Whoop Up Paint Stakes in September, then finished the year winning the Canadian Paint Championship. She was named the 2011 Canadian/International Champion with a speed index of 99 and \$22,735 in earnings. Unfortunately, days after winning the championship, she passed away after returning home to Stony Plain, Alberta, Canada.

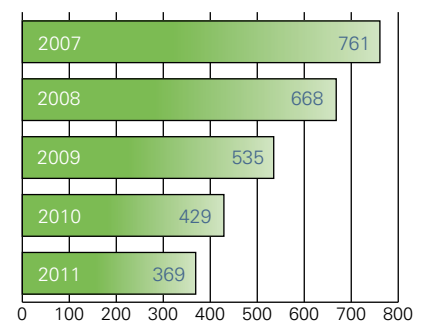
The Paint Horse racing industry also lost two wonderful women. Lorelei Welch of Sallisaw, Oklahoma—the namesake of the Lorelei Paint and Appaloosa Derby—loved colorful horses and was an artist who also made trophy blankets for many racetracks nationwide. Betty Lasiter, also of Sallisaw, Oklahoma, passed away in 2011. Betty was the longtime nominations clerk for Blue Ribbon Downs.

APHA launched a new program, the APHA Masterpiece Racing Challenge, which provides added

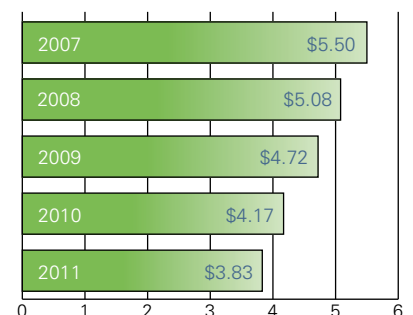
Number of Starters

The 2010 Paul Harber Distinguished Service Award was presented to John and Neva Downing of Rifle, Colorado, at the 2011 Parade of Champion banquet. Their continued support and involvement in breeding and racing Paint Horses expands more than 40 years with a total of 489 Paints.

2010 Racing World Champion I Do One Two Three received additional recognition when his half-brother, Cold Cash 123, won the Rainbow Derby, was the fastest qualifier to the All-American Derby and was named the 2011 AQHA World Champion. Walter and Carolyn Bay of Claire, Michigan, own both champions.

Real Easy Cash joined the \$1 million sire club by becoming the eighth stallion to reach this achievement. The 1998 bay tobiano stallion by Easy Jet Too was bred by Royse R Ranch of El Reno, Oklahoma, and is currently owned by Carlos Deleu of Brazil.

Paint Racing finished the year with 473 starters, 369 races and \$3,827,692 in purse money, with the G1 *Speedhorse* Graham Paint & Appaloosa Futurity offering the largest purse of \$246,242. The leading money-earners for 2011 were all related. Flashthechicks was the leading money-earner with earnings of \$186,007, his sire Royal Quick Flash was the 2011 leading sire of money-earners and his dam Game Chicken was the 2011 leading dam of money-earners. Judys Lineage remained at the top as the leading lifetime stallion and the only stallion whose offspring's earnings have exceeded the \$4 million mark, totaling \$4,529,866.

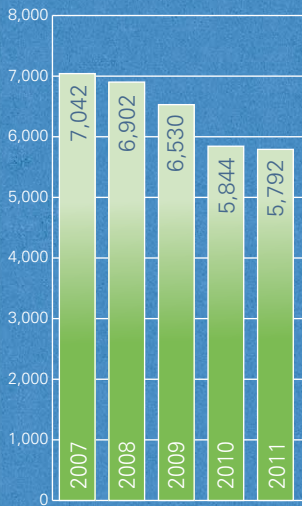

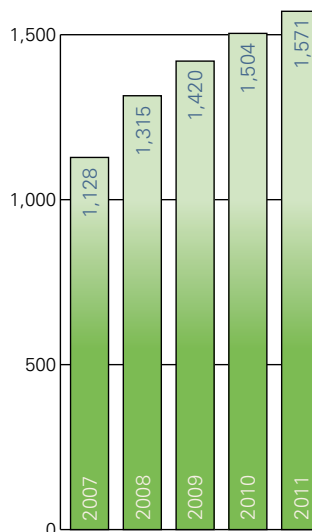


Independent Auditor's Report

1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Organization and Nature of Activities

The American Paint Horse Association, Inc. (The Association) is a not-for-profit membership organization incorporated under the laws of Texas and exempt from income tax under Section 501(c)(5) of the U.S. Internal Revenue Code. The Association was formed in 1962 to collect, record, and preserve the pedigree of Paint Horses. In addition, the Association is responsible for promoting and disseminating knowledge and information related to the Paint Horse breed.

Basis of Accounting

The accounts are maintained and the financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Under the accrual basis of accounting, the Association's financial statements reflect significant receivables, payables, and other liabilities.

Basis of Presentation and Revenue Recognition

The Association is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted, temporarily restricted, and permanently restricted net assets. The Association has no permanently restricted net assets.

Membership dues and subscription fee revenues are recognized over the applicable membership or subscription period. All other revenue is recognized in the period in which the services are provided. Breeders Trust and Breeders Futurity ("Breeders' Trust Programs") support is recognized as temporarily restricted net assets and will be released from restrictions in the applicable distribution years. (See Note 3. RESTRICTED PROGRAMS, Breeders' Trust Programs.)

Notes to Financial Statements

Cash and Cash Equivalents

For purposes of these financial statements, the Association considers cash to be all cash on hand, cash in banks in demand accounts, cash in investment brokerage money market accounts, as well as amounts deposited in U.S. Treasury backed money market accounts. Cash, restricted, is cash deposited specifically for the Breeders' Trust Programs and is held in separate accounts.

Accounts Receivable

Accounts receivable are included in the accompanying statements of financial position at original invoice net of the allowance for doubtful accounts. The accounts receivable balance is comprised of amounts owed to the Association for magazine advertising and other miscellaneous receivables.

The Association determines its allowance based on specific uncollectible accounts. The Association writes off receivables when they become uncollectible. The Association has had minimal losses on accounts receivable in prior years. The allowance for doubtful accounts in 2011 and 2010 is \$6,000 and \$15,000 respectively.

Fair Value of Financial Instruments

The carrying value of the Association's financial instruments, not otherwise disclosed herein, is comparable to the fair value due to the short-term nature of these financial instruments.

Investments

The Association carries investments in marketable securities with readily determinable fair values and all investments in debt securities at their fair values in the statement of financial position. The Association has investments in Structured Investments (See Note 4. INVESTMENTS, UNRESTRICTED) with embedded derivatives, which are financial instruments whose performance is linked to that of an underlying asset or assets. The Structured Investments are bonds with various embedded market indices used to hedge against interest rate fluctuations. The Association's investment policy allows for the use of derivatives for this purpose. Unrealized gains and losses of all investments are included in the change in net assets in the accompanying statement of activities.

General Store Inventory

The APHA General Store Collection held for resale and Promotional inventory is carried at the lower of cost or market determined by first-in, first-out method. Annual merchandise write-downs to market of all items determined to be slow moving or obsolete are reflected on the statements of activities under Program Services, General store. Write-downs for the years ending December 31, 2011 and 2010 were \$3,282 and \$23,269 respectively.

Property, Equipment, Depreciation and Collections

Property and equipment is stated at cost. Depreciation is computed using the straight-line method over the estimated useful lives of the related assets, which range from 3-40 years. For marketing furniture and equipment, APHA capitalizes everything in excess of \$400. For all other fixed asset categories, APHA capitalizes everything in excess of \$1,000.

The Association possesses various prints, original paintings and bronze sculptures purchased and carried at their cost or received as unrestricted gifts and carried at their estimated fair value. These works of art are on display and were not purchased or received for the purpose of re-sale. These items are not depreciated. (See Note 7, PROPERTY AND EQUIPMENT, Collectibles)

Income Taxes

The Association is exempt from federal income taxes under Section 501(c)(5) of the Internal Revenue Code. The accounting standard on accounting for uncertainty in income taxes, which addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under this guidance, the Association may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities, based on the technical merits of the position. Examples of tax positions include the tax-exempt status of the Association and various positions related to the potential sources of unrelated business taxable income (UBIT), such as advertising in the Association's magazine.

The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate

settlement. There were no unrecognized tax benefits identified or recorded upon ultimate settlement. There were no unrecognized tax benefits identified or recorded as liabilities for 2011 or 2010.

The Association files forms 990 and 990-T in the U.S. federal jurisdiction. The Association is generally no longer subject to examination by the Internal Revenue Service for years before 2008.

Functional Allocation of Expenses

The costs of providing the activities of the Association have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

Advertising

Advertising is recorded as an expense when incurred. For the years ended December 31, 2011 and 2010, advertising expense was approximately \$137,872 and \$103,209, respectively.

Concentration of Credit Risk

The Association maintains cash balances at certain financial institutions, which at times may exceed the federally insured amount. The Association has not experienced any losses due to these concentrations.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual result could differ from those estimates.

Reclassifications

Certain accounts in the prior-year financial statements have been reclassified for comparative purposes to conform with the presentation in the current-year financial statements.

3. RESTRICTED PROGRAMS

Breeders' Trust Programs

The Association provides added incentives for Paint Horse owners who exhibit their horses. The Breeders Trust, established in 1994, pays cash awards for points earned at Association approved events by nominated horses. The Breeders Trust paid out \$ 859,651 in 2011 and \$ 1,131,375 in 2010. Breeders Futurity, established in 2009, pays cash awards for placings earned at Association approved events by nominated horses. The Breeders Futurity paid out \$ 52,448 in 2011 and \$ 35,978 in 2010. The Breeders Trust and the Breeders Futurity (the "Breeders' Trust Programs") are accounted for as restricted programs and as such are reported in the Association's financial statements as temporarily restricted net assets due to the nature of the programs. (See Note 5. INVESTMENTS, RESTRICTED Breeders' Trust Programs.)

6. FAIR VALUE MEASUREMENTS

The revised guidance for fair value measurements defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the assets or liability. The price in the principal (or most advantageous) market used to measure the fair value of the asset or liability shall not be adjusted for transaction costs. An orderly transaction is a transaction that assumes exposure to the market for a period prior to the measurement date to allow for marketing activities that are usual and customary for transactions involving such assets and liabilities; it is not a forced transaction. Market participants are buyers and sellers in the principal market that are (1) independent, (2) knowledgeable, (3) able to transact and (4) willing to transact.

The guidance for fair value measurements for financial assets and financial liabilities requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. The market approach uses prices and other relevant information generated by market transactions involving identical or comparable assets and liabilities. The income approach uses valuation techniques to convert future amounts, such as cash flows or earnings, to a single present amount on a discounted basis. The cost approach is based on the amount that currently would be

required to replace the service capacity of an asset (replacement cost). Valuation techniques should be consistently applied. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the guidance establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

Level 1 Inputs – Unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2 Inputs – Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These might include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability (such as interest rates, volatilities, prepayment speeds, credit risks, etc.) or inputs that are derived principally from or corroborated by market data by correlation or other means.

Level 3 Inputs – Unobservable inputs for determining the fair values of assets or liabilities that reflect an entity's own assumptions about the assumptions that market participant would use in pricing the assets or liabilities.

A description of the valuation methodologies used for assets measured at fair value, as well as the general classification of these assets pursuant to the valuation hierarchy, is set forth below.

10. EMPLOYEE BENEFIT PLANS

401(k) Plan

The Association participates in a defined contribution plan under section 401(k). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and qualifies for its deferral arrangement under U.S. Internal Revenue Code 401(k). The Plan covers all employees with one year of service over the age of 21 that work at least 1,000 hours within the previous year. The Plan has a noncontributory portion with a 5% contribution rate of eligible employees' wages. The Association may match any eligible participants' contributory deferral to a maximum of 5% of their pre-tax compensation. Total expenses for the years ended December 31, 2011 and 2010 were \$8,971 and \$10,921, respectively.

Deferred Compensation Agreement

The Association has entered into an eligible non-qualified deferred compensation agreement that covers the Executive Director under U.S. Internal Revenue Code 457(b). This is a noncontributory plan with annual deferral amounts set by the U.S. Internal Revenue Code.

11. COMMITMENTS

Operating Leases

The Association leases certain pieces of office equipment and storage space under non-cancelable operating leases that expire at various dates through May 2017. For the year ended December 31, 2011, the leases required monthly payments of approximately \$9,051. Rental expense for those leases was approximately \$112,338 for the year ended December 31, 2011. 12. RELATED PARTIES

American Paint Horse Foundation

The Foundation is a separate corporation (not-for-profit) organized for the purpose to reward and educate young horsemen and women and to preserve the history of the breed's accomplishments and artifacts associated with the outstanding bloodlines of the breed and individuals and institutions who contributed to these accomplishments. It is chartered as a non-profit corporation in the state of Texas and is exempt under U.S. Internal Revenue Service Revenue Code 501(c)(3) as a charitable publicly supported organization under 509(a)(1).

The Association contributes to the Foundation the accounting, managerial and administrative services necessary for the ordinary day-to-day operations. During 2011 and 2010, the amount of like-kind contributions to the Foundation in expenses and services rendered amounted to \$19,900 and \$29,780, respectively. In addition, the Association made unrestricted contributions in 2011 and 2010 of \$4,401 and \$10,252, respectively.

13. SUBSEQUENT EVENTS

In preparing these financial statements, the Association has evaluated events and transactions for the potential recognition or disclosure through March 7, 2012. In February 2012, the Association entered into a three-year contract with a new executive director.



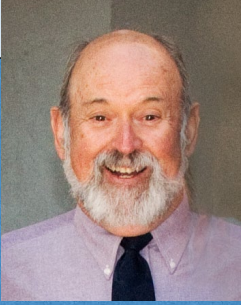


Independent Auditor's Report

Notes to Financial Statements

1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Organization and Nature of Activities

The American Paint Horse Foundation (Foundation) is organized for the purpose to reward and educate young horsemen and women and to preserve the history of the breed's accomplishments and artifacts associated with the outstanding bloodlines of the breed and individuals and institutions who contributed to these accomplishments. The Foundation resulted from a merger in 2005 between the American Paint Horse Heritage Foundation and the American Paint Horse Association Youth Development Foundation. It is chartered as a non-profit corporation in the state of Texas and is exempt under U.S. Internal Revenue Service Revenue Code 501(c)(3) as a charitable publicly supported organization under 509(a)(1).

Basis of Accounting

The accounts are maintained and the financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Under the accrual basis of accounting, the Foundation's financial statements reflect significant receivables, payables, and other liabilities.

Basis of Presentation and Revenue Recognition

The Foundation is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted, temporarily restricted, and permanently restricted net assets. The Foundation has permanently restricted net assets of \$822,992 as of December 31, 2011 and \$805,179 as of December 31, 2010.

Contributions received and fund raising income is recognized in the period in which the services are provided.

Cash and Cash Equivalents

For purposes of these financial statements, the Foundation considers cash to be amounts in demand accounts and money market accounts. Cash, restricted, is cash deposited specifically determined by the donor's intent.

Accounts Receivable

Accounts receivable are included in the accompanying statements of financial position at the original invoice amount. The accounts receivable balance is comprised of amounts owed to the American Paint Horse Association ("Association") and other miscellaneous receivables. (See Note 6, RELATED PARTY.)

The Foundation does not have an allowance for doubtful accounts, as management believes that all of its receivables are fully collectible.

Fair Value of Financial Instruments

The carrying value of the Foundation's financial instruments, not otherwise disclosed herein, is comparable to the fair value due to the short-term nature of these financial statements.

Notes to Financial Statements

Investments

The Foundation carries its investments in debt securities and common stock equities at their fair values in the statement of financial position. Unrealized gains and losses of all investments are included the change in net assets in the accompanying statement of activities.

Inventory

The bronze collection inventory held for resale is carried at the lower of cost or market determined by the first-in, first-out method.

Property, Equipment, Depreciation and Collections

Property and equipment is stated at cost. Depreciation is computed using the straight-line method over the estimated useful lives of the related assets, which is 4 years. The Foundation capitalizes asset improvements and additions in excess of \$500.

The Foundation possesses various prints, original paintings and bronze sculptures purchased and carried at their cost or received as unrestricted gifts and carried at their estimated fair value. These works of are on display and were not purchased or received for the purpose of re-sale. These items are not depreciated. (See Note 5, PROPERTY, EQUIPMENT AND COLLECTIONS.)

Income Taxes

The Foundation is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code. The accounting standard on accounting for uncertainty in income taxes addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under this guidance, the Foundation may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities, based on the technical merits of the position. An example of a tax position is the tax-exempt status of the Foundation.

The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. There were no unrecognized tax benefits identified or recorded upon ultimate settlement. There were no unrecognized tax benefits identified or recorded as liabilities for 2011 or 2010.

The Foundation files Form 990 in the U.S. federal jurisdiction. The Foundation is generally no longer subject to examination by the Internal Revenue Service for years before 2008.

Advertising

Advertising is recorded as an expense when incurred. For the years ended December 31, 2011 and 2010, advertising expense was approximately \$7,900 and \$17,780, respectively.

Concentration of Credit Risk

The Foundation maintains cash balances at certain financial institutions, which at times may exceed the federally insured amount. The Foundation has not experienced any losses due to these concentrations.

Notes to Financial Statements

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. RESTRICTED PROGRAMS

The Foundation has permanently restricted endowments with investment income restricted for scholarship purposes. At December 31, 2011 and 2010, permanently restricted net asset balances were \$822,992 and \$805,179, respectively

3. INVESTMENTS, RESTRICTED

The Foundation has restricted investments in common stock equities through professionally managed funds. The restricted investments held by the Foundation on December 31, 2011:

4. FAIR VALUE MEASUREMENTS

The FASB guidance for fair value measurements defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. A fair value measurement assumes that the transaction to see the assets or transfer the liability occurs in the principal market for the assets or liability. The price in the principal (or most advantageous) market used to measure the fair value of the asset or liability shall not be adjusted for transaction costs. An orderly transaction is a transaction that assumes exposure to the market for a period prior to the measurement date to allow for marketing activities that are usual and customary for transactions involving such assets and liabilities; it is not a force transaction. Market participants are buyers and sellers in the principal market that are (1) independent, (2) knowledgeable, (3) able to transact and (4) willing to transact.

The guidance for fair value measurements for financial assets and financial liabilities requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. The market approach uses prices and other relevant information generated by market transactions involving identical or comparable assets and liabilities. The income approach uses valuation techniques to convert future amounts, such as cash flows or earnings, to a single present amount on a discounted basis. The cost approach is based on the amount that currently would be required to replace the service capacity of an asset (replacement cost). Valuation techniques should be consistently applied. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the guidance establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

Level 1 Inputs—Unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2 Inputs—Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These might include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability (such as interest rates, volatilities, prepayment speeds, credit risks, etc.) or inputs that are derived principally from or corroborated by market data by correlation or other means.

Level 3 Inputs—Unobservable inputs for determining the fair values of assets or liabilities that reflect an entity's own assumptions about the assumption that a market participant would use in pricing the assets or liabilities.

6. RELATED PARTY

A portion of the Foundation's day-to-day functions are conducted by employees of the American Paint Horse Association (Association). The Association is a separate corporation (not-for-profit) organized for the purpose of collecting, recording and preserving the pedigree of the Paint Horse. The Foundation is managed by a board of directors which consists of members of the Association. These services and expenses are listed as an unrestricted support contribution and then as corresponding expenses per the criteria for recognition under generally accepted accounting principles. At December 31, 2011 and 2010, the amount of like-kind contributions was \$19,900 and \$29,780, respectively. In addition, the Association made unrestricted contributions in 2011 and 2010 of \$4,401 and \$10,252, respectively.

7. SUBSEQUENT EVENTS

Management has evaluated subsequent events through March 28, 2012, which is the date the financial statements were available to be issued. No material subsequent events occurred through March 28, 2012.
