For Broodmares and Stallions Only

INCLUDE A COPY OF THE CERTIFICATE OF REGISTRATION AND APPROPRIATE FEES WITH THIS APPLICATION. APPLICATIONS WITHOUT A COPY OF REGISTRATION PAPERS MAY BE DELAYED IN PROCEEDING.

An Accredited Texas-Bred Broodmare and/or Stallion must be registered with the APHA, AQHA, or Jockey Club and complete accreditation with the TPHBA as breeding stock. ATB Stallions must be permanently domiciled in Texas. Any horse accredited with TPHBA as racing stock must be re-accredited as breeding stock to participate as an ATB broodmare or stallion.

REQUIREMENTS FOR ACCREDITED BREEDING STOCK

BROODMARE – A mare must be registered with the APHA, AQHA, or Jockey Club and complete accreditation with the TPHBA as breeding stock.

All foals of an ATB broodmare that are foaled in Texas are eligible for accreditation as ATB racing stock provided the ATB broodmare is bred to a stallion, which is accredited with TPHBA, at least every other breeding. TPHBA may require breeders to submit, to TPHBA, a Stallion Breeding Report for ATB broodmare bred to verify eligibility for accreditation.

STALLION – Stallions must be permanently domiciled in Texas, registered with the APHA, AQHA, or Jockey Club and complete accreditation with the TPHBA as breeding stock.

A stallion must stand the entire breeding season in Texas. A stallion may leave the state for racing or medical purposes if he returns to Texas each year before January 1. A stallion may not be accredited for a particular foal unless all foals conceived in that year, other than foals conceived by shipped semen process, were conceived in Texas.

	Stallion Late Annual Participation	\$150	\$200	If paid after April 15 th and on or prior to December 31 st of participation year.
