All foals must be parentage verified. APHA Regular Registry foals must have one APHA Regular Registry Paint Parent. APHA Solid Registry foals must have two APHA Regular Registry Paint Parents, OR at least one APHA Regular Registry Paint Parent in the 1st & 2nd generation. \*The Accredited Texas-bred money will be paid out in Futurity Trials, or Finals if no Trials are held, for the top three (3) finishing Accredited Texas-Bred Paint Horses. ATB money to be divided 50%, 30%, 20%. If less than three (3) ATB horses start the ATB money will be distributed evenly to the remaining horses. TPHBA will retain 15% of the gross purse (excluding added money) for cost of advertising and administration.**
