- The Regional Club Advisory Committee will develop a Zone By-Law template which will be posted on the Regional Club website for Zone Coordinating Committee's reference. They will be notified of such posting.
- 2. Zone Committees will be required to submit Zone documents by March 1 of each calendar year which will coincide with the Regional Club submission deadline. (Currently they are not required to submit the documents until they apply for a Zone show.)
- 3. Reduce the required documents for Sponsoring a Zone Show to only the copies of the letters sent to each club asking if they would like to participate in the Zone Show and their

- responses. All other documents as outlined in the Rule Book should be retained by the Zone Coordinating Committee for possible submission during Zone review.
- 4. Zones will be reviewed every other year for compliance using the Zone Review Checklist as a guide. If a Zone does not pass review, a Zone show will not be approved for that year review and if the Zone show has already been approved it will be placed back as Pending until the Zone has come into compliance.
