Accredited Texas-Bred Racing Stock includes all horses registered with APHA, accredited with the TPHBA, foaled in Texas and out of an Accredited Texas-Bred Broodmare which is permanently domiciled in Texas.

For a foal to be eligible for accreditation, it must also be consecutively or alternately sired by an Accredited Texas-Bred Stallion. If a foal is conceived by an Accredited Stallion that loses his eligibility during the breeding season, the foal is still eligible to become an accredited Texas-Bred if he is foaled in Texas.

An Accredited TPHBA Broodmare is a mare registered with the APHA, AQHA, or Jockey Club and accredited with the TPHBA for breeding purposes and permanently domiciled in Texas except for medical, racing, and breeding privileges. The TPHBA must be notified in writing within ten (10) calendar days each time the mare leaves and enters the state. Annual reproductive activity of the mare must be reported to the TPHBA in writing using forms provided by TPHBA. Mares must be accredited by December 31st of the year of conception of an accredited Texas-Bred. Broodmares have a one-time lifetime accreditation.

An Accredited TPHBA Stallion is a stallion registered with the APHA, AQHA, or Jockey Club and accredited with the TPHBA, that stands the entire breeding season in Texas. He shall be permanently domiciled in Texas from February 1 to July 31, except for medical or racing privileges, but shall not be bred to a mare in North America outside the state of Texas within that breeding season. A stallion may enter the program after February 1, if under his current ownership he has never been a stallion accredited with the Texas Paint Horse Breeders Association. The TPHBA must be notified in writing within ten calendar days each time the stallion leaves or enters the state of Texas. Annual Stallion Breeding Reports must be submitted in writing to the TPHBA office on or before the date

required by the American Paint Horse Association (November 30 of the breeding year). Failure to supply the Stallion Report will result in loss of accreditation status and loss of owner's eligibility to receive Stallion Owner Awards. Stallions must be accredited by February 1 of the year prior to siring accredited Texas-Bred.

TPHBA Membership

To become a TPHBA member or renew a membership, *please check the appropriate box under the TPHBA Fee Schedule.*

TPHBA FEE SCHEDULE:

MEMBERSHIP: \$25 Individual or Family Membership \$250 Lifetime Membership

BROODMARE: \$50 One-time, lifetime accreditation fee

STALLION: \$50 One-time, lifetime accreditation fee (1st time accredited)

- \$50 Annual Administrative fee to maintain stallion's accreditation. This annual fee is payable on or before February 1 of each year.
- \$150 Late administrative fee (if paid after February 1). Late administrative fees will not be accepted if post-marked after December 31.

RACING STOCK:

- \$25 Weanling – by December 31 of the foal's weanling year
- \$50 Yearling – by December 31 of the foal's yearling year
- \$500 Racing Age – by January 1 of the horse's two-year-old year

GRANDFATHER CLAUSE:

Any horse foaled in Texas will be eligible for Texas Accreditation. The owner of the accredited racing stock will be eligible for Accredited Texas-Bred money in races along with Accredited Texas-Bred year-end awards. Under this clause the stallion owner and breeder will not be eligible for Accredited Texas-Bred year-end awards. If mare is not an Accredited Texas-Bred broodmare, at the time of enrolling foal, the broodmare accreditation fee will double (\$100).

- \$100 Weanling – by December 31 of the foal's weanling year
- \$200 Yearling – by December 31 of the foal's yearling year
- \$300 by January 1 of the horse's two-year-old year and older Racing Stock

*****If the mare is not a TPHBA Accredited Broodmare at the time of accrediting her foal, cost to accredit broodmare will be double (\$100).***

TRANSFER:

- \$15 Transfer of ownership or leases (after horse has been accredited). The TPHBA office must be notified in writing of these transactions via the appropriate TPHBA form.
