## 2021 APHA Stallion Service Auction

### APHA Stallion Service Conditions

The APHA Stallion Service Auction was established as a primary fundraiser to help ensure the growth and progress of APHA Paint Racing.

Participation in the 2021 APHA Stallion Service Auction is open to owners of registered American Paint Horse, Appaloosa, American Quarter Horse and Thoroughbred stallions for which at least one 2021 breeding has been donated.

The stallion owner/donor must agree to the following:

1. The stallion owner/donor is responsible for sending their original breeding contract to the mare owner.
2. If the stallion is sold anytime during the stallion auction, the donor of the stallion breeding must immediately notify APHA.
3. The stallion owner may charge the mare owner normal mare care charges and any other applicable fees such as chute fees, veterinary fees, semen shipping fees, etc. Mare owners must contact the breeding facility to inquire about any additional fees or shipping fees.

Once the breeding has been sold, APHA will distribute contact information to both parties. The stallion owner/breeding facility and purchaser will make all breeding arrangements. APHA is not responsible for booking dates or any additional fees associated with this breeding. Winning bids must be paid within 5 working days by check, credit card or cashiers check. If not paid within allotted timeframe, APHA collection procedures will be implemented.

### Stallion Service Auction

1. After a stallion has been donated to the 2021 APHA Stallion Service Auction, services are offered for sale by competitive online bidding at the APHA Website: [apha.com/racing](http://apha.com/racing).
2. Any breeding purchased through the 2021 APHA Stallion Service Auction must be used by purchaser and may not be transferred or re-sold by the buyer.
