

Her advice to new judges:

"Enjoy what you do. Do not overlook talent for turn-out, and follow your instinct. Be positive when you judge. We need to appreciate all levels of competition and remember that everybody started somewhere!"




IN MEMORIAM

- 1. Don't book the last flight of the day. Flights are canceled often.

The answer was C! A judge would apply a ½-point penalty for departing a circle and jogging less than 2 strides. Walking would reduce the maneuver if poorly executed. The horse would then receive a 1-point penalty for being out of lead for one stride.
