

For 2024 Breeding Year

Please Note the Following Instructions:

- The stallion subscription must be made in the exact name of the stallion's owner or the lessee on record with APHA. If someone other than the recorded owner or lessee wishes to subscribe the stallion, then a waiver available through APHA must be signed by owner or lessee. If mare owner or resulting foal owner requests waiver, late fees will be waived through May 15 of foaling year.
- 2. The stallion subscription fee is paid in two installments. Overall stallion subscription fee will never exceed the stallion's highest advertised stud fee for that breeding year, unless late fees are incurred. Stallions standing for the first time have until March 31 of the breeding year to pay the initial enrollment fee without penalty. If a stallion is purchased between February 1 and June 30, the stallion can be subscribed without a late fee if the initial subscription fee is postmarked within 30 days of the date of purchase. Exclusions include transferring from single name to joint name and vice versa, from one member of the same household to another, or to or from an entity owned in part or in whole by the previous owner.

Initial subscription fee is due by January 31 of the breeding year.
